COVID-19 RESIDENT RELIEF FUND

Early in the pandemic, Pennrose Foundation created the COVID-19 Resident Relief Fund to provide support to residents of Pennrose properties who were facing adverse effects caused by the new coronavirus (COVID-19).

The Fund assists residents who are unable to access food safely and/or afford enough food to feed their family, or who are experiencing financial hardships from loss of employment and are unable to pay for essential living expenses other than food.

Nearly 160 residents have received support from the Fund in the form of financial support for living expenses or food security relief.

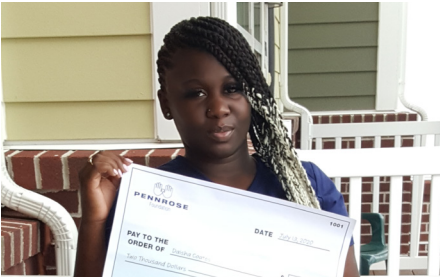
