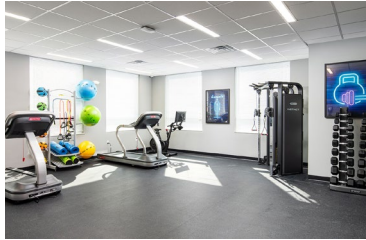

HOW TO APPLY FOR LOTTERY

Complete the property Pre-application, available for download on **HeightsatVPR.com**. Please contact us if you need a Pre-application emailed or mailed to you. Paper applications can be picked up from the brochure box outside the Community Building located at 99 Park River Drive, Hartford, CT 06112. Return the completed, signed, and dated Lottery Pre-application via email (HeightsVPR@pennrose.com) or via US MAIL to: **Pennrose, Attn: Heights at VPR, 1301 N. 31st Street, Philadelphia, PA 19121**. Upon receipt of the Application, credit, criminal, and landlord screening will be processed.

To be entered into the lottery, the Pre-application must be submitted via email or postmarked no later than **9/11/25**. The lottery will be conducted via Microsoft Teams at 2:00 pm on 9/22/25. A link to register to virtually attend is available at HeightsatVPR.com. It is not necessary to attend the live virtual lottery as your placement in the lottery will be mailed to you. 44 units will be filled through the housing lottery, while the remaining 32 units will be allocated through referrals.
