PROGRAMS AND ELIGIBILITY

Soria offers the following rent programs: Low-Income Housing Tax Credit, HOME Program, Project Based Vouchers, Housing Trust Fund

HOW TO APPLY

Complete the Online Application, available at **SoriaApts.com**. Screening charges will apply unless the applicant provides an official state criminal background and a credit report.

If there is an available unit that your household qualifies for, you will be contacted to schedule an application interview. Please plan to bring the following:

- Social Security Card(s) for each household member.
- Original Birth Certificate(s) for each household member.
- Addresses of your employer, bank, Social Security Office, and all other information pertaining to income.

If there are no units currently available that your household qualifies for, you will be mailed a Confirmation of Pre-application via U.S. Mail and placed on the property's waiting list. You will be contacted when a unit that your household qualifies for becomes available. Upon submission of your completed Application, credit, criminal, and landlord screening will be processed.
