Phase IV adds an additional 60 units to the existing 200, for a total of 260 units. The new family rental development is located in Hartford, CT and consists of high-quality energy efficient one-, two-, and three-bedroom professionally managed residences. Totalling six phases when complete, Village at Park River will consist of over 400 units of mixed-income townhouse-style homes, bike paths, community gardens and playgrounds, a community building with fitness center and a meeting space, and a central park.

- Original Birth Certificate(s) for each household member.
- Addresses of your employer, bank, Social Security Office, and all other information pertaining to income.

Upon payment of the Application Fee, credit, criminal, and landlord screening will be processed.
